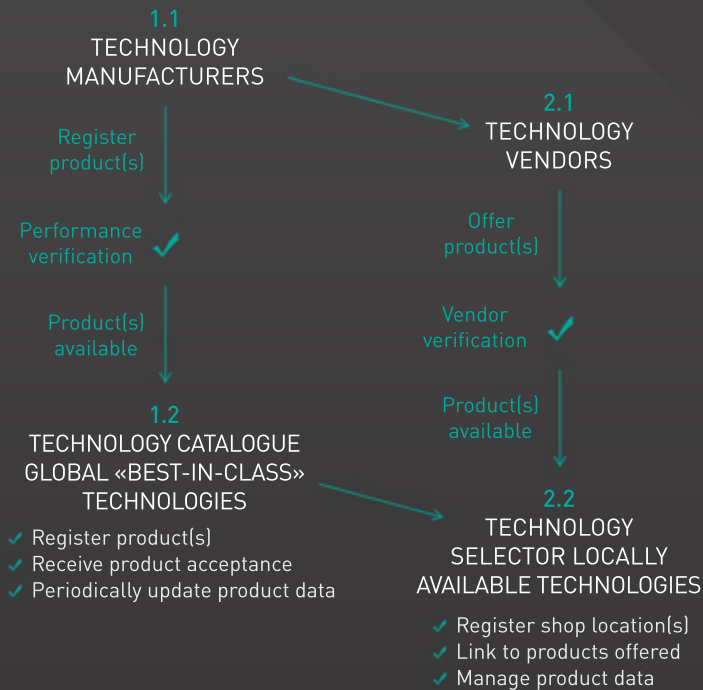


HOW DOES IT WORK?

By selecting to browse products in a country, the Green Technology Selector will list the technologies that meet the minimum performance criteria for that country.

Products listed in the country-specific Green Technology Selector meet technical performance criteria (“pre-approved”) and are considered pre-approved for green financing via partnering financial institutions.

Technology vendors and manufacturers are encouraged to register for free their technologies with this tool to make the best ones more visible to prospective local clients.

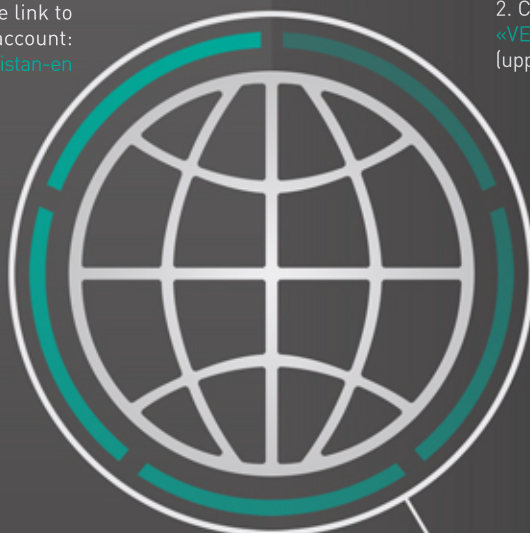

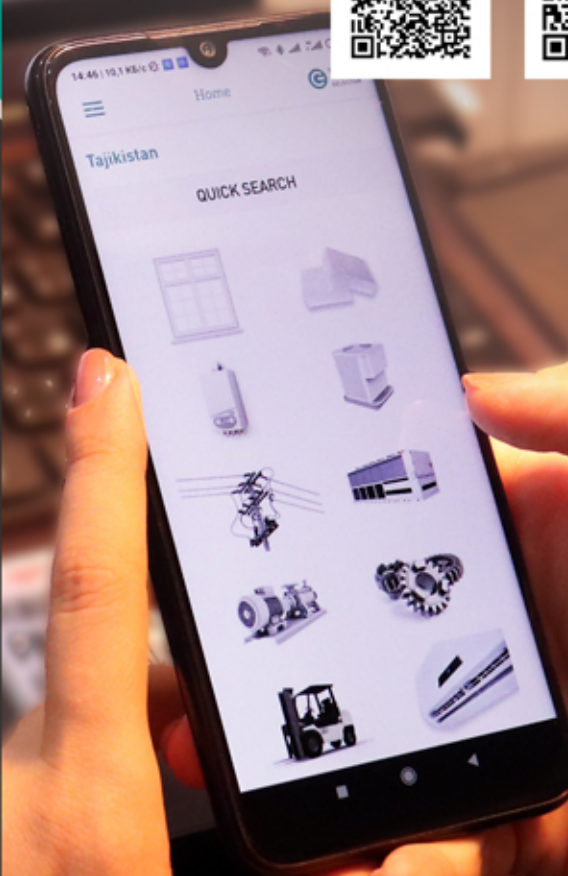
